PAYMENTS

Tuition must be paid in advance of care. There are ten equal monthly payments. The first payment is due August 1. The remaining payments are due the 15th day of each month beginning September 15 and ending May 15. If the first monthly payment and completed Contract is received by July 1 the registration fee will be discounted to \$25.

 Non-Payment will result in denial of care.
 All changes in enrollment for the following month must be received in writing by the 12th day of the preceeding month.
 Monthly tuition payments remain the same regardless of holidays, Winter Break, Spring Break, inclement weather, vacation, illness, pandemic or acts of nature.
